Chalice Lighter rolls in the Pacific Southwest District continue to increase, and your donations provide much needed support for growth in the PSWD, one congregation at a time.

The next call will be in support of the Unitarian Universalist Church of Ventura, CA. In 2008 UUCV adopted a new mission statement and approved an ambitious Five Year Plan aimed at growing the congregation and increasing their social justice work. Many of the components of this plan required increased staffing and in spite of the serious economic downturn they have made real progress toward their goals. They have increased the Coordinator of Religious Education position to 25 hours per week; have funded a part-time coordinator for the Lift Up Your Voice social justice project, partially through grant funding in addition to their contributions. The next step in the Five Year Plan is the addition of an assistant minister, to promote further growth in this active, dynamic congregation. The minister has been hired, now they need some help with the funding of this new position.
